An application has been filed against the Company under Section 7 of the Insolvency and Bankruptcy Code, 2016 read with Rule 4 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules 2016, by IDBI Bank Limited ("**the Bank**"), claiming to be a financial creditor, before the Hon'ble National Company Law Tribunal, Mumbai Bench for initiation of Corporate Insolvency Resolution Process against the Company, claiming a default of Rs.149,60,69,763/-.

The Bank's purported claim arises under a Debt Service Reserve Agreement entered into by the Bank and the Company for the financial facility availed by Siti Networks Limited. The Company is vehemently disputing the Bank's claim in other proceedings filed by the Bank against the Company for recovery of its alleged dues.
